The Wayne County Board of Commissioners met in regular session on Tuesday, November 1, 2016 at 9:07 a.m. in the Commissioners Meeting Room in the Wayne County Courthouse Annex, Goldsboro, North Carolina, after due notice thereof had been given.

Members present: Joe Daughtery, Chairman; William H. Pate, Vice-Chairman; George Wayne Aycock, Jr.; John M. Bell; Edward E. Cromartie; A. Joe Gurley, III and E. Ray Mayo.

Members absent: None.

Work Session

During the scheduled briefing and prior to the regularly scheduled meeting, the Board of Commissioners held an advertised work session to discuss the items of business on the agenda.

Closed Session

At 8:23 a.m., upon motion of Commissioner A. Joe Gurley, III, the Board of Commissioners unanimously declared itself in closed session to consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body, which privilege is hereby acknowledged.

Public Comments

Tom Drew stated he was concerned about election rules and laws, elections and liaisons in government.

Appointment – Wayne County Veterans Services Advisory Board

Upon motion of Commissioner A. Joe Gurley, III, the Board of Commissioners unanimously appointed Andrew A. Southerland to fill the unexpired term of Carl Groover on the Wayne County Veterans Services Advisory Board. Mr. Southerland's term will expire on May 6, 2018.

Public Hearing – Proposed Wayne County Minimum Housing Standards for Wayne County, North Carolina

At 9:35 a.m., the Board of Commissioners held a public hearing to receive public comments on the proposed Wayne County Minimum Housing Standards for Wayne County, North Carolina.

Planning Director Chip Crumpler reviewed the proposed Wayne County Minimum Housing Standards for Wayne County, North Carolina, attached hereto as Attachment A. The proposed ordinance takes the mobile home setup standards ordinance (adopted October 17, 2006) and combines it into a minimum housing standards ordinance, which specifically addresses all types of structures including site built housing and manufactured housing.

The proposed Minimum Housing Standards Ordinance for Wayne County, North Carolina includes the following:

- Application of ordinance to all types of construction
- Minimum standards for site built dwellings
 - Structural condition
 - Plumbing
 - Heating
 - Electrical
 - Ventilation
 - Standards for space
 - Control of insects, rodents and infestations
- Minimum standards for manufactured houses
 - HUD requirement and tax permits

- Exterior condition
- Doors and windows, under pinning
- Structural condition
- Electrical
- Heating
- Plumbing
- Responsibilities of owners and residents
- County responsibilities

Planning Director Chip Crumpler stated the proposed Minimum Housing Standards Ordinance deals with all types of housing – stick built and manufactured houses. He reviewed the proposed ordinance. Upon request of the County Manager, a public officer or a written request of five adult residents of the county, the Director of Inspections or his designee shall investigate the dwelling and the dwelling conditions in order to determine if the dwelling unit is unfit for human habitation. A Housing Appeals Board will be created to hear appeals.

Shirley Edwards questioned where the Wayne County Minimum Housing Standards for Wayne County, North Carolina document was available for viewing. She stated the proposed ordinance was a good idea.

Planning Director Chip Crumpler stated the Wayne County Minimum Housing Standards for Wayne County, North Carolina was available for viewing on the County of Wayne website and the Wayne County Planning Department.

At 9:38 a.m., Chairman Joe Daughtery adjourned the public hearing.

Adoption of Wayne County Minimum Housing Standards for Wayne County, North Carolina

Upon motion of Vice-Chairman William H. Pate, the Board of Commissioners unanimously adopted the Wayne County Minimum Housing Standards for Wayne County, North Carolina, attached hereto as Attachment A.

Presentation of New Meadow Lane Elementary School

Wayne County Public Schools Superintendent Dr. Michael Dunsmore introduced Randy Baker and Dr. Jim Watson with Pinnacle Architecture, who updated the Board of Commissioners on the plans for the new Meadow Lane Elementary School.

The new Meadow Lane Elementary School will have approximately 115,000 square feet and accommodate 900 students. The school is brick veneer with a pitched roof. The building will have a kindergarten and first grade wing, a wing for the second and third grade and a wing for the fourth and fifth grade. Each classroom in the kindergarten and first grade wing will have a restroom located inside the classroom. Each wing also has a group restroom. Other features include a cafeteria, gym, library, bus entrance, computer room, music and art rooms, central storage facility and a teacher workroom on each wing. Bids for Phase 1 of the construction will be solicited in spring 2017. It anticipated the school will be open for the 2018-2019 school year.

The existing Meadow Lane Elementary School will remain in operation for the construction of Phase 1 with some classrooms being demolished. After Phase 1 is completed, the existing Meadow Lane Elementary School will be demolished for Phase 2.

The new Meadow Lane Elementary School will have a separate, but attached, wing for exceptional students. These students are currently housed at Edgewood Community Developmental School. This wing will be constructed in Phase 2, which could start in June 2018.

Guilford County has a similarly designed elementary school by Pinnacle Architecture in use. Onslow County is constructing an elementary school of similar design. The HVAC is self-contained for easier maintenance. The utilization of solar energy has not been discussed.

In response to questions from Commissioner Edward E. Cromartie, Wayne County Public Schools Superintendent Dr. Michael Dunsmore stated there will be fencing around the school. The proposed soccer fields behind the school will be used prior to the new school opening. The Wayne County Board of Education has not discussed the exact placement of the fencing. The money has been predicated for the Southern Wayne High School project and Pinnacle Architecture is reviewing the drawings for the project. It is anticipated the Southern Wayne High School project will be completed when the Phase 1 of the new Meadow Lane Elementary School has been completed.

Commissioner E. Ray Mayo stated former Seymour Johnson Air Force Base 4th Fighter Wing Commander Col. Mark Slocum was adamant about needed security at Meadow Lane Elementary School. Plans need to be made now for school security. We need to make our schools 100% secure.

Update of the Wayne County Internet Broadband Survey Project

Planning Director Chip Crumpler stated Wayne County has been working with the North Carolina Broadband Infrastructure Office to gather un-served and under-served addresses in an effort to help providers identify and consider deployment options in areas where a need for internet broadband service has been identified. The county received over 650 responses to its survey of need. The county will be hosting a meeting of broadband providers to provide the demand information, including the addresses, which will be shared in an effort to spur discussion and consideration of potential solutions. The county also has assets that may help future deployment efforts and is willing to consider proposals that will aid in helping the citizens and businesses in Wayne County enjoy a more robust broadband experience. The meeting of the broadband providers will be held on November 2, 2016 at 3:00 p.m. in the 3rd floor conference room in the Jeffrey's Building, 134 N. John Street, Goldsboro, North Carolina.

Planning Director Chip Crumpler stated he had developed a request for proposals if there are no responses from wireless service providers.

Upon motion of Commissioner E. Ray Mayo, the Board of Commissioners unanimously approved the SEPI Engineering contract for the Canterbury Village and North Creek subdivisions street project, attached hereto as Attachment C and the associated Budget Amendment.

Accept and Award the Bid for Previously Declared Surplus Property at 212 Tina Avenue, Pikeville, North Carolina

The County of Wayne and Town of Pikeville previously declared surplus the jointly owned property located at 212 Tina Avenue, Pikeville, North Carolina. The property was auctioned off on the GovDeals.com website. A copy of the bid history is attached hereto as Attachment D. The highest responsible, responsive bidder was Tim Thomas in the amount of \$44,300.

Upon motion of Commissioner Edward E. Cromartie, the Board of Commissioners unanimously accepted and awarded the bid for the previously declared surplus property at 212 Tina Avenue, Pikeville, North Carolina to the highest responsible, responsive bidder Tim Thomas, 774 Driftwood Drive, Hampstead, North Carolina in the amount of \$44,300. Goldsboro-Wayne Transportation Authority Veterans Ride Free Promotion

Goldsboro-Wayne Transportation Authority Director Fred Fontana informed the Board of Commissioners about the veterans ride free promotion. All veterans and active military will be able to ride the urban buses for free on November 7-12, 2016. Riders will need to show either a military ID or a DD-214 (discharge paper) with picture identification. Anyone needing more information should call 919-736-1374.

Vice-Chairman William H. Pate thanked the Goldsboro-Wayne Transportation Authority Board of Directors for providing the veterans ride free promotion.

Commissioner Edward E. Cromartie thanked Goldsboro-Wayne Transportation Authority Director Fred Fontana for his creative ideas to help the morale of the staff.

Commissioner E. Ray Mayo stated it was a privilege to serve on the Goldsboro-Wayne Transportation Authority Board of Directors. He also stated the latest financial report was good.

Approval of Detention Center Van, Inmate Transport Up-fit, Laundry Trailer and Budget Amendment

Sheriff Larry M. Pierce requested permission to purchase a 2017 Ford Transit-250 based medium roof cargo van for a Detention Center inmate van (\$25,509), inmate transport up-fit (\$19,841) and laundry trailer (\$4,028). The van and equipment will be needed when the Carey A. Winders Detention Center opens.

Upon motion of Commissioner George Wayne Aycock, Jr., the Board of Commissioners unanimously approved and authorized the purchase of a 2017 Ford Trans-250, inmate transport up-fit, laundry trailer and budget amendment #164 for the Detention Center.

Finance Director Allison Speight informed the Board of Commissioners the county spent \$27,000 in a 12-month period for laundry at the Detention Center.

Commissioner A. Joe Gurley, III thanked Wayne Memorial Hospital for doing the Detention Center laundry when the Cherry Hospital laundry facility was not operating.

Commissioner Edward E. Cromartie thanked the Sheriff's Office for supervising the pickup of trash.

Sheriff Larry M. Pierce stated 24,000 bags of trash have been picked up. Deputies will enforce the North Carolina General Statutes concerning littering.

Presentation of the Quarterly Financial Statement and Sales Tax for the County of Wayne for Fiscal Year 2016-2017 through September 30, 2016

Finance Director Allison Speight presented the quarterly financial statement and sales tax for the County of Wayne for fiscal year 2016-2017 through September 30, 2016, attached hereto as Attachment E.

Presentation of the Quarterly Financial Statement for the Wayne County Tourism Development Authority for Fiscal year 2016-2017 through September 30, 2016

Finance Director Allison Speight presented the quarterly financial statement for the Wayne County Tourism Development Authority for fiscal year 2016-2017 through September 30, 2016, attached hereto as Attachment F.

At 10:35 a.m., Chairman Joe Daughtery recessed the meeting. At 10:44 a.m., Chairman Joe Daughtery reconvened the meeting.

Work Session – Proposed Wayne County Special Events Ordinance

Planning Director Chip Crumpler reviewed the proposed Wayne County Special Events Ordinance, attached hereto as Attachment G.

The proposed Wayne County Special Events Ordinance establishes a structured process for permitting the staging of special planned public events, and/or television and film activities to ensure proper planning and adequate allocation of county resources for events and to protect the health and safety of the public attending such events.

The proposed Wayne County Special Events Ordinance will not apply to events sponsored by local, state or federal government agencies; or schools located in Wayne County since the planning for these events and allocation of necessary resources is already coordinated. The ordinance shall not apply to regular church or worship activities or events. The ordinance shall not apply to businesses holding events in venues designated to hold large numbers of people, where there is already a safety and emergency plan approved by the county.

The following is addressed in the proposed Wayne County Special Events Ordinance:

- When is a permit required
- Process of applying for a permit
- What agencies review the application for a permit
- Conditions of obtaining a permit
- Requirements for events that routinely have more than 2,500 persons
- Exemptions
- Standards under which a permit is issued
- Approval time frame
- Proof of compliance with certain standards
- Additional standards for television and film events
- Required fees
- Revocation of the permit
- Appeals
- Penalty

Key points in the proposed Wayne County Special Events Ordinance include:

- Events with 500 or more persons are required to have a permit.
- Businesses that routinely have 2,500 or more persons in attendance must have a permanent permit issued for general operating conditions. If a special event is held where the attendance more than doubles; then, the business will be required to obtain another permit for that specific event addressing the increased numbers.
- Permit applications will be received through the Wayne County Planning Department and routed through the Wayne County Office of Emergency Services for review by other agencies. The review and comment period must be completed within seven days of permit application submission.
- Fees for additional services may be required to be paid to the county. This fee schedule and the cost of the actual special events permit will be adopted by the Board of Commissioners in a fee schedule.

The proposed Wayne County Special Events Ordinance was reviewed by the County Attorney and the Office of Emergency Services.

In response to a question from Chairman Joe Daughtery, County Manager George A. Wood stated a special events ordinance is customary on the county level. Large events need law enforcement, fire protection and Emergency Medical Services. The county can be caught off guard in providing the needed services if there is no advance notice of the special event. Extra staff may need to be brought in to handle the needs. The sponsors of the special event need to pay for the additional services provided.

Planning Director Chip Crumpler stated the North Carolina Department of Transportation and State Highway Patrol need to be notified.

Commissioner A. Joe Gurley, III stated an evacuation plan is needed for a special event. The proposed ordinance does not apply to churches and schools. A large store holding a festival would be included in the proposed Wayne County Special Events Ordinance and require a permit.

Planning Director Chip Crumpler stated Busco Beach could have an event about which the county was not previously notified. Therefore, a safety and emergency plan would not be in place for resources such as traffic safety, crowd control and Emergency Medical Services. The Wayne Regional Fair has a safety and emergency plan in place. The new Maxwell Regional Agricultural and Convention Center will need to have a safety and emergency plan in place. The proposed Wayne County Special Events Ordinance applies to the unincorporated areas of the county, including the extraterritorial jurisdictional territories.

County Manager George A. Wood stated the Wayne County Special Events Ordinance and associated fee schedule would need to be adopted simultaneously. The ordinance can be amended after it is adopted with needed exemptions.

Commissioner George Wayne Aycock, Jr. stated when he ran for office he told citizens he was for less government involvement. The county is putting more restrictions on the sponsors of special events. As the part owner of a sports complex, he would recuse himself from voting on the proposed Wayne County Special Events Ordinance.

Planning Director Chip Crumpler stated the proposed Wayne County Special Events Ordinance only requires sponsors to apply for a permit and pay for additional services. The intent of the ordinance is to prevent the county from being mandated to provide services without prior notice. There is no cost for a permit application. If the county had to provide a large number of extra resources, the sponsor would be charged.

Commissioner E. Ray Mayo stated a private citizen may want to hold an event to do something for our citizens. He questioned if the proposed ordinance would be more applicable to people living outside of Wayne County.

County Attorney E. B. Borden Parker stated this would be a federal Constitution problem.

County Manager's Comments

County Manager George A. Wood stated the Wayne Executive Jetport lease has been completed and sent to UNC Healthcare. The county is trying to get operations back to normal after Hurricane Matthew and the subsequent flooding. The county is working on the construction and reconstruction debris removal contract.

County Manager George A. Wood stated Facility Services Director Kendall Lee informed him one of the two chillers at the Detention Center was lost. The staff obtained an emergency quotation of \$200,000 to build a new replacement chiller, which could take two to three months.

Board of Commissioners Committee Reports and Comments

Commissioner E. Ray Mayo stated the Department of Social Services Board meeting last week was very productive in discussing possible improvements to agency operations. He stated Goldsboro-Wayne Transportation Authority Director Fred Fontana was doing a good job.

Commissioner Edward E. Cromartie stated Goldsboro-Wayne Transportation Authority Director Fred Fontana was doing a good job. Yesterday he traveled around the county and talked with people displaced by Hurricane Matthew and the subsequent flooding. He discovered citizens in many parts of the county have suffered. Wayne County has much to do to recover from the devastation caused by Hurricane Matthew. He was informed a church was charged at the landfill for Hurricane Matthew storm related debris.

Commissioner A. Joe Gurley, III stated WATCH (Wayne Action Teams for Community Health) Chairman Sam Hunter and Board Member Murray Porter appreciated the county funding. The WATCH (Wayne Action Teams for Community Health) golf tournament grossed \$125,000. He thanked everyone involved with the golf tournament for its success.

Vice-Chairman William H. Pate stated the Wayne County Chamber of Commerce 7th Annual Leadership Luncheon was very good. Wayne County was recognized at the Eastern Carolina Workforce Development Board banquet.

Chairman Joe Daughtery stated early voting continues through Saturday. He encouraged everyone to vote on Election Day. He also encouraged everyone to attend the Veterans Day parade on November 11, 2016 at 11:00 a.m.



ARTICLE A Minimum Housing Standards – Site Built Dwellings

Section 1.

Finding: Purpose

(a) Pursuant to G.S. 160A-441, it is hereby found and declared that there exists in the County of Wayne dwellings which are unfit for human habitation due to dilapidation, defects increasing the hazards of fire, accidents and other calamities, lack of ventilation, light and sanitary facilities and due to other conditions rendering such dwellings unsafe or unsanitary, and dangerous and detrimental to the health, safety and morals, and otherwise detrimental to the welfare of the residents of the County.

(b) In order to protect the health, safety and welfare of the residents of the County as authorized by part 6 of article 19, chapter 160A of the General Statutes, it is the purpose of this article to establish minimum standards of fitness for the initial and continued occupancy of all buildings used for human habitation, as expressly authorized by G.S. 160A-444.

Section 2. Definitions.

The following definitions shall apply in the interpretation and enforcement of this article:

(1) *Basement* shall mean a portion of a building which is located wholly or partly underground, having direct access to light and air from windows located above the level of the adjoining ground.

(2) *Cellar* shall mean a portion of a building located partly or wholly underground having inadequate access to light and air from windows located partly or wholly below the level of the adjoining ground.

(3) *Deteriorated* shall mean that a dwelling is unfit for human habitation and can be repaired, altered, or improved to comply with all of the minimum standards established by this article, at a cost not in excess of fifty percent (50%) of its current tax value. The inspector shall make this determination.

(4) *Dilapidated* shall mean that a dwelling is unfit for human habitation and cannot be repaired, altered or improved to comply with all of the minimum standards established by this article at a cost not in excess of fifty percent (50%) of its current tax value. The inspector shall make this determination.

(5) *Dwelling* shall mean any building, structure, manufactured home or mobile home, or part thereof, used and occupied for human habitation or is intended to be so used, and includes any outhouses and appurtenances belonging thereto or usually enjoyed therewith, except that it does not include any manufactured home or mobile home which is used solely for a seasonal vacation purpose as defined in GS 160A-442.

(6) *Dwelling unit* shall mean any room or group of rooms located within a dwelling and forming a single habitable unit with facilities which are used or intended to be used for living, sleeping, cooking and eating.

(7) *Extermination* shall mean the control and elimination of insects, rodents or other pests by eliminating their harborage places; by removing or making inaccessible materials that may serve as their food; by poisoning, spraying, fumigating, trapping or by

any other recognized and legal pest elimination methods approved by the inspector.

(8) *Garbage* shall mean the animal waste and vegetable waste resulting from the handling, preparation, cooking and consumption of food; or other household items or useless materials that are worthless, unimportant or of poor quality and intended to be discarded.

(9) *Habitable room* shall mean a room or enclosed floor space used or intended to be used for living, sleeping, cooking or eating purposes, excluding bathrooms, water closet compartments, laundries, heater rooms, foyers, or communicating corridors, closets and storage spaces.

(10) *Infestation* shall mean the presence within or around a dwelling, of any insects, rodents or other pests in such number as to constitute a menace to the health, safety or welfare of the occupants or the public.

(11) *Inspector* shall mean a building inspector of the County or any agent of the inspector who is authorized by the inspector.

(12) *Manufactured Home* shall be: A residential dwelling unit, designed for transportation after fabrication on its own wheels or on flatbeds, or other trailers, and arriving at the site where it is to be occupied as a dwelling unit complete and ready for occupancy except for minor incidental unpacking and assembly operations including, but not limited to, location on jacks or other temporary or permanent foundation, and connection to utilities. Travel trailers, campers and recreational vehicles shall not be considered mobile homes. For the purposes of this ordinance, the term "mobile home" shall be inclusive of the term "manufactured home" as the term manufactured home is defined by the North Carolina General Statutes.

(13) *Modular Home* is a residential dwelling unit that is prefabricated offsite and assembled in sections onsite on a permanent foundation. Modular Homes are built to the standards of the North Carolina Building Code. This type of home is not considered a manufactured home.

(14) *Multiple dwelling* shall mean any dwelling containing more than two (2) dwelling units.

(15) *Occupant* shall mean any person, living, sleeping, cooking or eating in, or having actual possession of a dwelling unit or rooming unit.

(16) *Operator* shall mean any person who has charge, care or control of a building or part thereof, in which dwellings units or rooming units are let.

(17) *Owner* shall mean any person who alone, or jointly, or severally with others;
a. Shall have title to any dwelling or dwelling unit, with or without accompanying actual possession thereof; or b. Shall have charge, care or control of any dwelling or dwelling unit, as owner or agent of the owner, or as executor, executrix, administrator, trustee or guardian of the estate of the owner. Any such person thus representing the actual owner shall be bound to comply with the provisions of this article, and of rules and regulations adapted pursuant thereto, to the same extent as if he were the owner.

(18) *Plumbing* shall mean and include all of the following supplied facilities and equipment gas pipes, gas burning equipment, water pipes, mechanical garbage disposal units (mechanical sink grinder), waste pipes, water closets, sinks; installed dish- washers, lavatories, bathtubs, shower baths, installed clothes washing machines, catch basin, drains, vents and any other similar supplied fixtures, together with all connections to water, sewer or gas lines.

(19) *Public authority* shall mean the County of Wayne or any

officer who is in charge of any department or branch of the government of Wayne County or the State of North Carolina relating to government of Wayne County or the State of North Carolina relating to health, fire building regulations, or other activities concerning dwellings in the County.

(20) *Recreation vehicle* shall mean a vehicular, portable structure built on a chassis, with permanent wheels, designed to be used as a temporary dwelling for travel, recreational and vacation used towed or driven and having a width not in excess of eight feet.

(21) *Rooming unit* shall mean any room or group of rooms forming a single habitable unit used or intended to be used for living and sleeping, but not for cooking or eating purposes.

(22) *Rooming house* shall mean any dwelling, or that part of any dwelling containing one or more rooming units, in which space is let by the owner or operator to three (3) or more persons who are not husband and wife, son or daughter, mother or father or sister or brother of the owner or operator.

(23) *Rubbish* shall mean combustible and noncombustible waste materials except garbage and ashes, and the term shall include paper, rags, cartons, boxes, wood, excelsior, rubber, leather, tree branches, yard trimming, tin cans, metals, minerals matter, glass crockery and dust.

(24) *Stick Built home* shall be defined as: A home that is "stick-built" is constructed on the building site, piece by piece. Manufactured and modular homes are not classified as stick-built because they are made mostly in the factory and then transported to the site. A custom home and a homemade according to stock building plans may both be stick-built, provided that they are constructed on the land where they will remain.

(25) *Supplies* shall mean paid for, furnished or provided by, or under the control of, the owner or operator.

(26) *Temporary housing* shall mean temporary migrant labor housing.

(27) *Transportable housing* shall mean any tent, trailer or other structure used for human shelter which is designed to be transportable and which is not attached to the ground, to another structure, or to any utilities system.

(28) *Unfit for human habitation* shall mean that conditions exist in a dwelling which violate or do not comply with one (1) or more of the minimum standards of fitness or one or more of the requirements established by this article.

(29) *Meaning of certain words.* Whenever the words "dwelling, dwelling unit, rooming house, rooming unit, premises" are used in this article they shall be construed as though they were followed by the words "or any part thereof."

Section 3. Minimum standards of fitness for dwellings and dwelling units.

Every dwelling and dwelling unit used for human habitation except transportable and temporary housing (excluding mobile homes) or held out for use as a human habitation, shall comply with all of the minimum standards of fitness for human habitation and all of the requirements of Sections 4 to 8 of this chapter. No person shall occupy as owner-occupant, or let to another for occupancy or use as a human habitation, any dwelling or dwelling unit which does not comply with all of the minimum standards

of fitness for human habitation and all of the requirements of Sections 4 to 8.

Section 4. Minimum standards for structural condition

- (a) Walls, floors and roofs shall not have rotted, deteriorated, or damaged supporting members to a point where the structural integrity would not be reasonably safe for the purpose used.
- (b) Foundations, foundation walls, piers or other foundation supports shall not be deteriorated or damaged to a point where the supporting strength would not be safe for the purpose used.
- (c) Stairs, porches, and appurtenances. Every outside and inside stair, porch, and any appurtenance thereto shall be safe to use and capable of supporting the load that normal use may cause to be placed thereon.
- (d) Egress. Every dwelling unit shall be provided with adequate means of egress as required by the State Residential Building Code (Volume 1-B of the State Building Code).
- (e) The roof, flashings, exterior walls, basement walls, floors and all doors and windows exposed to the weather shall be constructed and maintained so as to be reasonably weather and watertight.
- (f) There shall be no chimneys or parts thereof which are defective, deteriorated or in danger of falling, or in such condition or location as to constitute a fire hazard.
- (g) There shall be no use of the ground for floors, or wood floors on the ground.

Section 5. Minimum standards for basic equipment and facilities.

(a) Plumbing system.

(1) Each dwelling unit shall be connected to a potable water supply and to the public sewer or other approved sewage disposal system.

(2) Each dwelling unit shall contain the, following as required by the State Plumbing Codes; a kitchen sink, lavatory, tub or shower, water closet, and adequate supply of both cold water and hot water. All water shall be supplied through an approved pipe distribution system connected to a potable water' supply.

(3) All plumbing fixtures shall meet the standards of the State Plumbing Code and shall be maintained in an operable condition.

(4) All required plumbing fixtures shall be located within the dwelling unit and be accessible to the occupants of same. The water closet and tub or shower shall be located in a room or rooms affording privacy to the user.

(b) Heating system. Every dwelling unit shall have facilities for providing heat in accordance with either (1) or (2) below.

(1) Central and electric heating systems. Every dwelling unit should have facilities provided to heat the dwelling to a temperature of 68° Fahrenheit at 3 feet above floor level during ordinary winter conditions.

(2) Other heating facilities. Where a central or electric heating is not provided, each dwelling and dwelling unit shall be provided with sufficient fireplaces, chimneys, flues or gas vents whereby heating appliances may be connected so as to heat all habitable rooms with a minimum temperature of sixty eight (68) degrees Fahrenheit measured three (3) feet above the floor during ordinary winter conditions.

(c) Electrical system.

- (1) Every dwelling and dwelling unit shall be wired for electric lights and convenience receptacles. Every habitable room shall contain at least two (2) floor or wall-type electric convenience receptacles, connected in such manner as determined by the National Electrical Code at the time the home was built. There shall be installed in every bathroom, water closet room and laundry room, at least one supplied ceiling, or wall-type electric light fixture. In the event wall or ceiling light fixtures are not provided in any habitable room, then each such habitable room shall contain at least (3) floor or wall-type electric convenience receptacles.
- (2) Every public hall and stairway in every multiple dwelling shall be adequately lighted by electric lights at all times when natural daylight is not sufficient.
- (3) All fixtures, receptacles, equipment and wiring shall be maintained in a state of good repair and safe. All repairs, replacements and additions shall be installed in accordance with the National Electrical Code.
- (4) All electrical devices, switch and receptacle covers, and light fixtures must be in place and properly secured. All homes without smoke detectors must have an approved smoke detector outside bedroom areas.

Section 6. Minimum standards for ventilation.

- (a) General. Except when provided with mechanical ventilation, every habitable room shall have an operable window, the size of which shall be not less than eight percent (8%) of the floor area of such room.
- (b) Bathroom and water closet rooms. Every bathroom and water closet compartment shall comply with the light and ventilation requirements for habitable rooms except that no window or skylight shall be required in adequately ventilated bathrooms and water closet rooms equipped with an approved ventilation system.

Section 7. Minimum standards for space, use, and location

- (a) Room sizes. Every dwelling unit shall contain at least the minimum room size in each habitable room **as required by the State Residential Building Code (Volume I-B of the State Building Code) and stated below:**
 - (1) Every dwelling unit shall contain at least one hundred and fifty (150) square feet of habitable floor area for the first occupant, at least one hundred (100) square feet of additional habitable area for each of the next three (3) occupants, and at least seventy-five (75) square feet of additional habitable floor area for each additional occupant.
 - (2) In every dwelling unit and in every rooming unit, every room occupied for sleeping purposes by one (1) occupant shall contain at least seventy (70) square feet of floor area, and every room occupied for sleeping purposes by more than one (1) occupant shall contain at least fifty (50) square feet of floor area for each occupant twelve (12) years of age and over and at least thirty-five (35) square feet of floor area for each occupant under twelve (12) years of age.
- (b) Ceiling height. At least one-half (1/2) of the floor area off every habitable room shall have a ceiling height of not less than seven (7) feet and six (6) inches.
- (c) Floor area calculation shall be as required by the State Residential Building Code (Volume I-B) and as stated below. Floor area shall be calculated on the basis of habitable room area. However, closet area and wall area within the dwelling unit may count for not more than ten percent (10%) of the required habitable floor area. The floor area of any part of any room where the ceiling height is less than four and one-half (4 1/2) feet shall not be considered as part of the floor area computing the total area of the room to determine maximum permissible occupancy.

Section 8. Minimum standards for control of insects, rodents, and infestations.

- (a) Screens. In every dwelling unit, for protection against mosquitoes, flies, and other insects, every door opening directly from a dwelling unit to outdoor space shall have supplied and installed screens; and every window or other device with openings to outdoor space, used or intended to be used for ventilation, shall likewise be supplied with screens installed. If central heating and air conditioning is provided then no screens are required.
- (b) Infestation. Every occupant of a dwelling containing a single dwelling unit shall be responsible for the extermination of any insects, rodents, or other pests therein or on the premises; and every occupancy of a dwelling unit in a dwelling containing more than one (1) dwelling unit shall be responsible for such extermination whenever his dwelling unit is the only one infested. Whenever infestation is caused by failure of the owner to maintain a dwelling in a reasonably rodent and insect proof condition, extermination shall be the responsibility of the owner. Whenever infestation exists in two (2) or more dwelling units in any dwelling or in the shared or public parts of any dwelling or in the shared or public parts of any dwelling containing two (2) or more dwelling units, extermination shall be the responsibility of the owner.
- (c) Garbage storage and disposal. Every dwelling unit in a multiple unit facility shall be supplied with an approved garbage disposal facility.

ARTICLE B – Minimum Housing Standards – Manufactured Homes

Section 1. Purpose: No manufactured home set up in Wayne County's jurisdiction after the effective date of this Ordinance shall have electric service initiated to it without meeting the following requirements:

- (a) Home must meet HUD construction requirements.
 - a. All manufactured homes being set up in Wayne County must bear a HUD data plate stating the home was constructed under regulations of HUD as of July 1, 1976 or later. All setup and installation of homes shall be in accordance with the setup and installation standards of the North Carolina Department of Insurance code regulations.
- (b) Exterior siding must be either painted or stained wood such as board and batten or board-on-board, Masonite, simulated stucco, residential grade metal, or vinyl lap siding. All siding shall be in good condition, complete, not damaged or loose.
- (c) All repairs made to the exterior of manufactured homes shall be made consistent with the original intent or integrity of the manufactured home. (For example, if repairs are made to the siding, material as close to or consistent with the original siding shall be used.)
- (d) Each manufactured home shall either have a brick curtain wall, ABS plastic color skirting with interlocking edges (key locked) or PVC painted metal approved skirting installed around the perimeter of the manufactured home. The skirting shall be attractive and in good condition, not pierced and shall be laid-up in an attractive, workmanlike manner. Any curtain wall or skirting shall have at least one door to enable access to the space below the manufactured home. All skirting shall have a frame sufficient to hold it in place. If the required skirting is greater than 36" in height, additional framing for support is required.
- (e) All windows and doors shall be intact, have no missing glass and in good working condition.
- (f) Permanent steps for the manufactured home shall meet the North Carolina Building Code and shall be installed.

(g) All electrical devices, switch and receptacle covers, and light fixtures must be in place and properly secured. All homes without smoke detectors must have an approved smoke detector installed outside each bedroom areas.

(h) All walls, floors and ceiling must meet the standards in Section 4 (a) (b) (c).

(i) Heating must comply with Section 5 (b).

(j) All plumbing must meet the requirements of Section 5 (a) (1) (4).

Section 2. Mobile Home Tax Permits

No manufactured home set up in Wayne County's jurisdiction after the effective date of this Ordinance shall have electric initiated to it without having a mobile home tax permit as required by NCGS 105-316.1 through 105-316.5. Such mobile home tax permits shall be obtained from the tax collector of the County from which the mobile home was moved and from the Wayne County tax collector if moved within Wayne County.

Section 3. Definitions are the same as in article A.

ARTICLE C – Responsibilities of Owners and Occupants

Section 1. Purpose to define the responsibilities of owners and occupants

(a) Public areas. Every owner of a dwelling containing two (2) or more dwellings units shall be responsible for maintaining in a clean and sanitary condition the shared or public areas of the dwelling and premises thereof.

ARTICLE D – Responsibilities of the County

Section 1. Purpose to define the duties of building inspector and/or County representative

The Director of Building Inspections or his designee is hereby designated as the officer to enforce the provisions of this article and to exercise the duties and powers herein prescribed.

(1) Upon the request of, the County Manager, a public officer or a written request of five adult residents of the County, the Director of Inspections or his designee shall investigate the dwelling and the dwelling conditions in order to determine if the dwelling unit is unfit for human habitation.

(2) To take such action, together with other appropriate departments and agencies, public and private, as may be necessary to effect rehabilitation of housing which is deteriorated:

(3) To keep a record of the results of inspections made under this article and an inventory of those dwellings that do not meet the minimum standards of fitness herein prescribed and;

(4) To perform such other duties as may be herein prescribed.

Section 2. Powers of building inspector

The building inspector is authorized to exercise such powers as provided by N.C. General Statutes.

Section 3. Inspection; duty of owners and occupants

Complaints or orders issued by the inspector shall be served upon persons either personally or by registered or certified mail, but if the whereabouts of such persons are unknown and the same cannot be ascertained by the inspector in the exercise of reasonable diligence, the inspector shall make an affidavit to that effect, and the serving of such complaint or order upon such person may be made by publishing the same once each week for two (2) successive weeks in a newspaper, circulating in the County. Where service is made by publication, a notice of the pending proceedings shall be posted in a conspicuous place on the premises affected by the complaint or order.

Section 6. In rem action by inspector; placarding.

(a) After failure of an owner of a dwelling or dwelling unit to comply with an order of the inspector issued pursuant to the provisions of this article, and upon adoption by the governing body of an ordinance authorizing and directing him to do so, as provided by G.S. 160A -443(5) and Article D section 4: c of this article, the inspector shall proceed to cause such dwelling or dwelling unit to be repaired, altered, or improved to comply with the minimum standards of fitness established by this article or to be vacated and closed and remodeled or demolished, as directed by the ordinance of the governing body and shall cause to be posted on the main entrance of such dwelling or dwelling unit a placard with the following words: "This building is unfit for human habitation; the use or occupation of this building for human habitation is prohibited and unlawful." Occupation of a building so posted shall constitute a misdemeanor.

(b) Each such ordinance shall be recorded in the office of the Register of Deeds in the county wherein the property is located, and shall be indexed in the name of the property owner in the grantor index as provided by G.S. 160A-443 (5)

Section 7. Costs, a lien on premises

As provided by G.S. 160A-446(6), the amount of the cost of any repairs, alterations, or improvements, or vacating and closing, or removal or demolition, caused to be made or done by the inspector pursuant to Article D section 6 shall be a lien against the real property upon which such cost was incurred. Such lien shall be filed, have the same priority, and be enforced and the costs collected as provided by article 10, chapter 160A of the General Statutes.

Section 8. Alternative remedies

Neither this article nor any of its provisions shall be construed to impair or limit in any way the power of the County to define and declare nuisances and to cause their abatement by summary action or otherwise, or to enforce this ordinance by criminal process as authorized by G.S. 14-4 and Article D section 8, and the endorsement of any remedy provided herein shall not prevent the enforcement of any other remedy or remedies provided herein or in other ordinances or laws.

Section 9. Housing Appeals Board.

There is hereby created a Housing Appeals Board to which appeals may be taken from decisions or orders of the inspector, as provided by Article D section 4 (d). The Board shall consist of the Wayne County Board of Commissioners or its designated appointees. The Board shall have the power to elect its own officers, to fix the times and places of its meetings, to adopt necessary rules or procedure and to adopt other rules and regulations for the proper discharge of its duties. The Board shall perform the duties prescribed by Article D section 4 (d) and shall keep an accurate record of all its proceedings.

Section 10. Conflict with other provisions.

In the event any provision, standard, or requirement of this article is found to be in conflict with any provision of any other "ordinance or code of the County, the provision which establishes the" higher standard or more stringent requirement for the promotion and protection of the health and safety of the residents of the County shall prevail.

Section 11. Violations: penalty.

(a) It shall be unlawful for the owner of any dwelling or dwelling unit to fail, neglect, or refuse to repair, alter, or improve the same, or to vacate and close and remove or demolish the same, upon order of the inspector duly made and served as herein provided, within the time specified in such order, and each day that any such failure, neglect, or refusal to comply with such order continues shall constitute a separate and distinct offense. It shall be unlawful for the owner of any dwelling or dwelling unit, with respect to which an order has been issued pursuant to Article D section 4, to occupy or permit the occupancy of the same after the time prescribed in such order for its repair, alteration or improvement or its vacation and closing, and each day that such occupancy continues after such prescribed time shall constitute a separate and distinct offense.


(b) The violation of any provision of this article shall constitute a misdemeanor as provided by G.S. 14-4, and shall be punishable by fine of fifty dollars (\$50.00) per offense per NCGS 14-4.

Section 12. Effective Date.

This ordinance shall become effective and be in full force from and after the 1st day of November, 2016 as adopted by the Wayne County Board of Commissioners. This ordinance is adopted this the 1st day of November, 2016.

**RESOLUTION DECLARING THE OFFICIAL INTENT OF
THE BOARD OF COMMISSIONERS TO REIMBURSE
EXPENDITURES BY THE COUNTY FOR STREET
IMPROVEMENTS FROM THE PROCEEDS OF A TAX
EXEMPT FINANCING**

Section 1. Section 1.150-2 of the Treasury Regulations (the "Regulations") prescribes specific procedures that are applicable to a tax-exempt financing issued or incurred by or on behalf of the County for which prior expenditures are to be reimbursed, including, without limitation, a requirement that prior to, or within sixty (60) days of, payment of the expenditures to be reimbursed the County declare its official intent to reimburse certain expenditures with proceeds of debt to be incurred by the County.

Section 2. The County is beginning to take actions towards the construction and acquisition of street improvements in the County (the "Project"). The Board hereby declares its official intent pursuant to Section 1.150-2 of the Treasury Regulations to reimburse itself from the proceeds of debt to be hereinafter incurred by the County for expenditures on the Project paid by the County on or after the date which is sixty (60) days prior to the date hereof except with respect to certain amounts incurred before such 60-day period not exceeding 20% of the issue price of the proceeds of the debt to be hereinafter incurred which are expended for "preliminary expenditures" within the meaning of Section 1.150-2 of the Treasury Regulations (the "Preliminary Expenditures"). Nothing contained herein shall prohibit the reimbursement for Preliminary Expenditures or other expenditures paid on an earlier date that may be reimbursed pursuant to applicable federal tax laws.

Section 3. \$2,250,000 is the maximum principal amount of debt reasonably expected to be incurred for the purpose of paying the costs of the Project.

Section 4. This resolution shall take effect upon its passage.

SEPI Engineering & Construction (SEPI) is pleased to provide Wayne County (Client) with this additional proposed Scope of Work and Fee Schedule to include design, contract documents for bidding and letting, and construction engineering and inspection (CEI) services necessary to construct the 2.4 miles of recommended roadway improvements within the Canterbury Village and North Creek subdivisions. These road improvements will, at a minimum, meet NCDOT's subdivision requirements for the roads in question to be added to the State maintained secondary road system.

The goal of this project is to make all required improvements to the roads within Canterbury Village in order that NCDOT will accept these roads onto the State maintained secondary road system. This proposal and scope of work, intends to address all aspects of designing and constructing the roadway improvements to ensure the roads within the project limits meet the requirements listed in the NCDOT standards for subdivision roads.

This proposal is limited to the improvements of the following roads:

SCOPE OF WORK

The scope of work SEPI is proposing to Wayne County concerning the design, construction documentation, and construction administration of the aforementioned roads in the Canterbury Village subdivision is as follows below. We have also provided our fee by task based on our understanding of the project as described above.

Topographic Survey & Hydraulic Design

SEPI will perform a location and elevation survey of selected pipes, ditch profiles and roadway cross sections. The expected horizontal and vertical accuracy will be +/- 0.10 foot. Approximately 20 crossline pipes are expected to be surveyed. For each crossline pipe the following will be obtained: inverts; adjacent toes of fill; shoulder points, pavement edge, and centerline across pipe profile; downstream cross section for outfalls; and bed profile 50 feet up and downstream. Lowest adjacent grade at some selected residences will also be obtained.

Project Engineers will use data obtained from survey to make pipe recommendations for those pipes crossing roadways that are hydraulically insufficient, structurally insufficient, or lack appropriate pipe cover. Ditches approaching cross pipes will be evaluated and recommendations made to clean out, re-grade, or modify ditch cross section as needed.

Pipe recommendations will be noted on Pipe Data Sheets which are used to analyze roadway pipe crossings using HDS 5 methods. Recommendations may be made to retain, remove and replace, or supplement existing pipes. Recommendations will also include pipe length, type, material, and invert elevations. Ditch recommendations will be made based up on manning's analysis for trapezoidal channels.

Project Design and Contract Documents

SEPI will complete the design of the project and the associated contract documents required for the bidding, letting and construction process including assisting the County in the bidding and letting process if necessary. We will create all necessary construction drawings from typical sections to alignments (if required) and produce the appropriate contract documents with specifications for construction. These documents will produce a complete and sufficient description of how to construct the recommended improvements.

We will also identify and address any utility encroachments encountered as a part of this task.

Construction Engineering and Inspection Services

SEPI will provide an onsite project representative/inspector when contractors are working during the course of the project to monitor contractor activities including: maintaining a daily diary, tracking material and work accomplished, and assuring that contract specifications are adhered to at all times. The presence of this personnel ensures that contract specifications are adhered to and that a quality and cost effective

product is delivered to the neighborhood and County. All personnel assigned to the project will be properly trained and certified by NCDOT in the required sampling and testing tasks to which they are assigned. The project representative/inspector will also monitor traffic control measures at all times and ensure all traffic control meets NCDOT standards.

SEPI will provide the onsite project representative at a fully-loaded rate of **\$75 per hour**. This rate includes all expenses associated with the onsite project representative including a vehicle, travel, and any other direct or indirect costs associated with this position.

The onsite project representative will be supervised by the project manager who will possess authority to make immediate decisions regarding adjustments to the plans or specifications as field conditions warrant.

SEPI's CEI portion of the work will be billed at the hourly rate of **\$75** plus any required material testing expenses estimated to be **\$3,000**. There are many variables that can affect the final CEI expenses, but a good rule of thumb is to estimate the construction engineering and inspection services will cost approximately 8% of the total project value. For this project our initial estimate for construction and CEI services is approximately \$2.14 million.



- 1) As of September 30, 2016, General Fund expenditures exceeded General Fund revenues by \$12,531,700. Of this amount, \$2,726,935 is unrestricted monies, leaving the remaining \$9,804,765 as restricted. The remaining restricted amounts are below:

- 2) As of September 30, 2015, General Fund revenues were under General Fund expenditures by -\$3,815,330. In comparison, at September 30, 2016, expenditures exceeded revenues by -\$12,531,700. The difference of \$8,716,370 is explained below:

- 3) As of September 30, 2016, total Sales Tax was at \$4,817,238 - excluding the new Article 44 receipts. At this time last year, the total was \$4,848,733 which is \$31,495 more than this year's cumulative total. However, all three articles are at 25% or higher of the budgeted amount which is an indication that we are still on track to collect what was budgeted for the year. A chart follows on the next page summarizing the last year's worth of data in sales tax collections, including the new Article 44 receipts. The chart also includes October collections since that information is available to us.

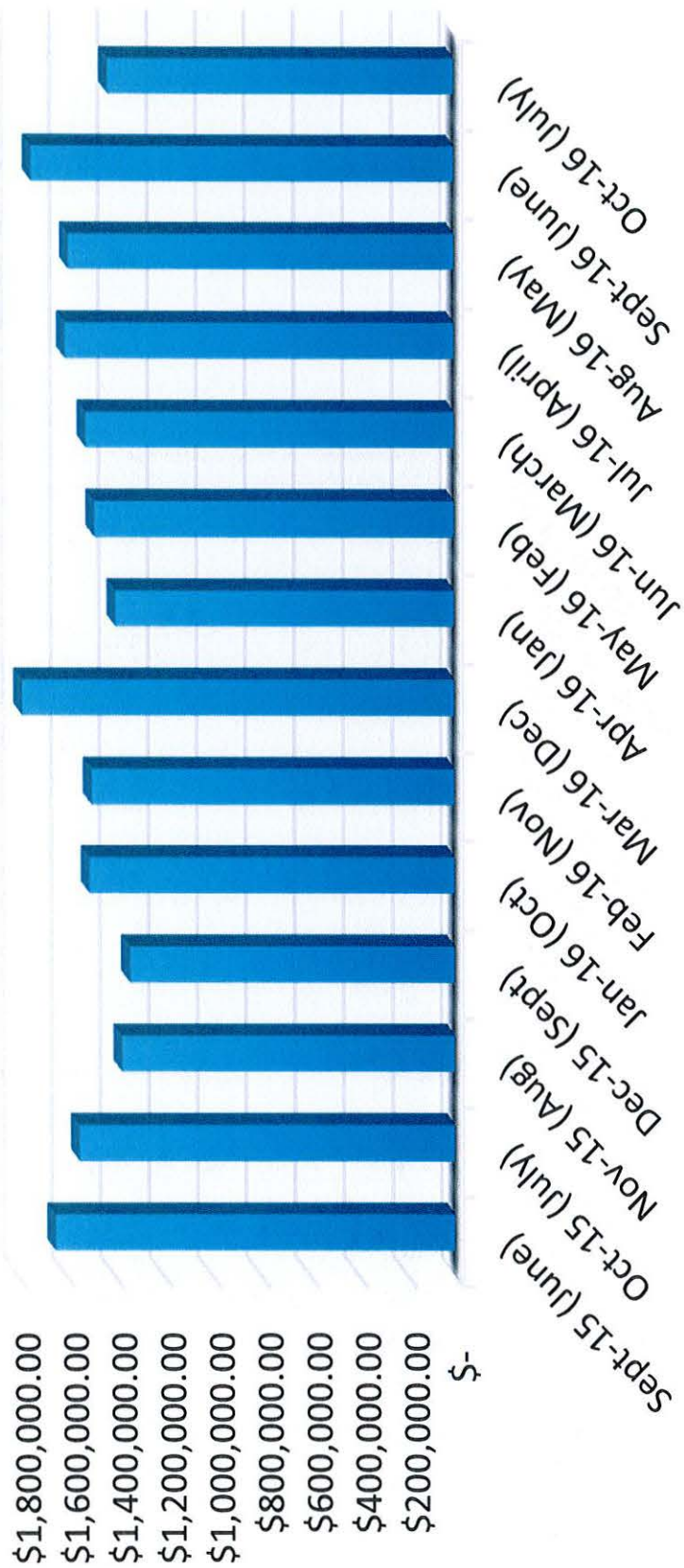

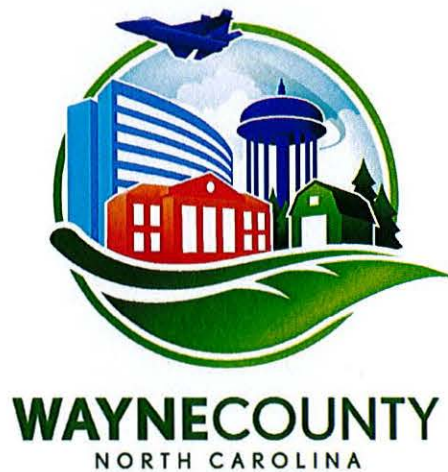

CHAPTER 47: SPECIAL EVENTS

Sec. 47.01 PURPOSE; SCOPE AND INTENT

(A) The purpose of this chapter is to establish a structured process for permitting the staging of special planned public events, and/or television and film activities to ensure proper planning and adequate allocation of county resources for events and to protect the health and safety of the public attending such events.

(B) This chapter will not apply to events sponsored by local, state or federal government agencies, or schools, colleges or universities located in Wayne County, as planning for events and allocation of necessary resources is already coordinated. This chapter shall not apply to regular church or worship activities or events. This chapter shall not apply to businesses holding events in venues designated to hold large numbers of people, where there is already a safety and emergency plan approved by the county.

(C) When it is determined that an event does not meet the threshold of requiring a permit, but notification of emergency first responders is recommended, the Planning Department will forward the Information to the appropriate agencies.

Sec. 47.02 DEFINITIONS

For purposes of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

COVERED EVENT: A special event that is not otherwise under the jurisdiction of another governing authority.

SPECIAL EVENT: Includes all planned events public or private where at least 500 individuals are expected to be in attendance in which any of the following may apply:

- (a) The use, sale or display of fireworks;
- (b) The sale, purchase, provision or consumption of alcoholic beverages;
- (c) The provision of live entertainment;
- (d) The provision of overnight activities (ex: camping);
- (e) Motorized or non-motorized vehicular racing or riding;
- (f) Activities located wholly or partially on public rights-of-way;
- (g) Sports that involves physical contact between participants as part of normal play;
- (h) A film or television production event is considered a special event under this chapter.

Activities contained in § 47.04 are specifically excluded from the definitions of a **SPECIAL EVENT**.

SANCTIONING AUTHORITY: The official governing body that sanctions specific events of the type being requested by an applicant, such as, but not limited to, racing authorities, public sports bodies and event associations.

Sec. 47.03 PERMIT REQUIRED

(A) No person shall have, hold, sponsor, or cause to be had, held, or sponsored, or allow to be had, held or sponsored any covered event without having first applied for and received a permit from the county, except as provided in § 47.04.

(B) All applications for covered event permits must be made through the Wayne County Planning Department. A completed application must be submitted for each event proposed. No application shall be considered submitted until, all information required on the application form has been provided.

(C) Applications for special event permits shall be submitted no less than 30 business days prior to the date of the covered event. The County Manager or his/her designee shall have the authority to reduce this time period for good cause shown. The appropriate fee in certified funds must accompany the application for it to be considered to have been filed.

(D) The Wayne County Planning Department will forward special event applications for review by the Wayne County Office of Emergency Services. Applications may be reviewed by the following agencies:

1. Sheriff's Office;
2. Emergency Medical Services;

3. Fire Marshal/Emergency Management;
4. Fire Department representative from district in which the event is planned;
5. Health Department/Environmental Health;
6. 911 Communications Center;
7. Planning and Inspections.

Review comments on the application are due within seven (7) days. If no comments are received within seven (7) days, the application may be approved and the permit may be issued.

For informational purposes the following organizations may also be notified:

1. North Carolina Department of Transportation (NCDOT);
2. NC Highway Patrol
3. Seymour Johnson Air Force Base

(E) The County may set conditions for permit approval. The applicant may be required to pay for fire/medical stand by and security/law enforcement in order for a permit to be approved. The applicant may be required to pay additional fees if county facilities/services are being used.

(F) All covered events must meet North Carolina Building Code, National Electric Code and ADA Requirements.

(G) Any person or business that routinely has 2500 or more persons in attendance must have a permanent special events permit issued for general operating conditions as well as an emergency operations plan filed with the Office of Emergency Services except as provided in § 47.04. Any additional event that increases the attendance more than double, shall require a new special events permit for that specific event or date except as provided in § 47.04 .

Sec. 47.04 EXEMPTIONS

This ordinance shall not apply to:

- (1) Any local, state or federal governmental agency acting within the scope of its governmental functions;
- (2) Any school, college or university operating in Wayne County;
- (3) Church or worship activities within a facility;
- (4) Businesses holding events in venues designated to hold large numbers of people, where there is already a safety and emergency plan approved by the county.

Sec. 47.05 STANDARDS FOR ALL COVERED EVENTS

A covered event shall be approved upon the completion of the application required herein, unless the application review finds one or more of the following:

- (1) The covered event time and location coincides with another covered event for which a permit has been issued, and it is determined that there is a safety or logistical concern with allowing two events to proceed simultaneously. Safety or logistical concerns could include, but not be limited to, events that would burden the resources of law enforcement or emergency services personnel, or would create the potential for traffic hazards;
- (2) The covered event will interrupt the safe movement of pedestrian or vehicular traffic at or contiguous to its location in a manner that cannot be adequately controlled by the public safety departments;
- (3) The concentration of persons, animals, and vehicles at assembly points for or at the location of the covered event will interfere with the county's ability to provide adequate fire, law enforcement and emergency medical services to the public; or
- (4) The Wayne County Health Department determines that the event plan does not account for and protect the public health and safety needs of the citizens of Wayne County.

(A) All covered events must comply with, and provide proof of compliance with the following:

- (1) All federal, state, local and event sanctioning authority mandated medical coverage requirements;
- (2) Wayne County EMS Medical Standards for Special Events, if applicable;
- (3) Wayne County EMS shall be the primary service provider for Wayne County;
- (4) All state, federal and local fire safety and prevention standards, codes and permitting requirements must be met. The Fire Department in the district where the event is to be held shall be primary and all others must function under the authority of that department;
- (5) For events where alcohol is provided, served, or sold, event organizer must secure a valid ABC permit. Copies of this permit must be forwarded to the Planning Department prior to the event;

- (6) Animals are not allowed at covered events unless as a specified part of an event and provided in the application therefore. Animals brought by spectators or participants, except service animals, shall not be allowed;
- (7) Event organizers shall remove all trash and debris and shall clean up immediately after a covered event;
- (8) The county, in its discretion, may require the applicant to provide liability and/or special events insurance coverage for the covered event;
- (9) Mass gatherings of 500 people or more must have a Crowd Control Manager ratio of 1 per 250 people or as otherwise required by the North Carolina Fire Code;
- (10) All road closures or events that will impact traffic must be approved by the NC Department of Transportation;
- (11) Submit a completed application, which shall contain the following information. Application will be critical in evaluating the citizen impact and public safety related to the event:
 - (a) General information related to the event such as:
 - 1. Whether amplified sound will be used;
 - 2. Whether vendors will be serving or cooking food;
 - 3. First aid plans;
 - 4. The number of toilets that will be accessible;
 - 5. Parking plans;
 - 6. Crowd control plan;
 - 7. Traffic control plan;
 - 8. Weather contingency plans;
 - (b) Information on county, and fire support services that may be required from:
 - 1. Security/law enforcement;
 - 2. Fire/rescue;
 - 3. Emergency medical services standby;
 - 4. Waste clean-up;
 - 5. Other (Health, Public Works).

Sec. 47.06 ADDITIONAL STANDARDS FOR TELEVISION AND FILM EVENTS

- (A) A pre-production meeting with Wayne County Office of Emergency Services or its designee must be held.
- (B) Proof of insurance certificates for the following must be submitted with the application:
 - (1) General liability insurance: \$2,000,000;
 - (2) Automobile liability insurance: \$2,000,000;
 - (3) Worker's Compensation insurance as required by statute and employer's liability insurance of \$1,000,000.
- (C) A security deposit of \$5,000 must be submitted with application.
- (D) It is the responsibility of the television or film company to notify the affected residents and/or businesses following the county's approval of the application and no less than three business days prior to the planned activity.
- (E) Production vehicles shall not block fire hydrants, driveways, or other access ramps unless authorized by Wayne County officials.
- (F) Production companies are responsible for vacating locations used with a minimum amount of noise and disruption at the end of each shooting day.
- (G) Any filming activity involving holding, delaying or rerouting of traffic in residential areas, or on state maintained road ways must be accompanied by at least one deputy sheriff.
- (H) The production company is fully responsible for clean-up and proper disposal of all waste and materials produced.
- (I) Removal or alteration of vegetation in the public right-of-way or on county owned lands is prohibited unless specifically approved by the film permit.

Sec. 47.07 PERMIT AND OTHER REQUIRED FEES

- (A) The schedule of fees for permitting and other associated fees for covered events in addition to those set herein shall be approved by the Board of County Commissioners.
- (B) If other fees for services are required, they must be paid by certified funds, prior to the event. If the event is canceled and the county is provided 24 hour's notice, the fees for stand by service will be refunded.
- (C) There may be other fire inspection, health and facility usage permits/fees that may be charged.
- (D) All permits pertaining to any special event must be obtained prior to the event and copies must be submitted to Planning Department (Ex: NCDOT, ABC permit).

Sec. 47.08 REVOCATION OF PERMIT

The County Manager, Planning Director or Office of Emergency Services Director, acting on behalf of Wayne County has the authority to revoke a special event permit if the holder of such permit fails to comply with the provisions of this chapter or other conditions stipulated in the permit.

Sec. 47.09 APPEALS

Any applicant shall have the right to appeal the denial of a special event permit, the conditions of a special event permit, or the revocation of a special event permit to the County Manager and then a further appeal may be made to the Board of County Commissioners. The appealing party shall make the appeal to the County Manager within five business days after receipt of the decision by Wayne County Office of Emergency Services. If the applicant wishes to appeal the County Manager's decision, the appeal must be included on the next Board of County Commissioners meeting agenda taking into account required agenda deadlines.

Sec. 47.99 PENALTY

- (A) It shall be unlawful for any person to:
 - (1) Hold a covered event without a required permit;
 - (2) Fail to terminate a covered event upon revocation of a permit;
 - (3) Conduct a covered event in violation of the terms and conditions of a permit issued for such event.
- (B) Any violation of the provisions of this chapter shall subject the offender to a civil penalty of \$500 for the first offense and \$1000 for a second and any subsequent offenses. Each day of violation shall constitute a separate offense. If a person fails to pay the civil penalties set forth herein within 20 days after being cited for a violation, the county may seek to recover the penalty by filing a civil action in the nature of debt.
- (C) The county, by and through its duly authorized authorities, may seek to enforce the provisions of this chapter through any appropriate equitable remedy issued from a court of competent jurisdiction.
- (E) A covered event for which a permit has not been approved, an event exempt from the chapter that otherwise would require a permit except for the exemption, or for which the stipulations of the permit which was approved are not met, or which is otherwise in violation of this chapter may be shut down by law enforcement, but only if either the County Manager, the Wayne County Sheriff or his designee determines that all of the following conditions are present:
 - (1) The covered event constitutes an immediate and direct physical danger to citizens or property; and
 - (2) The above danger is of such an imminent nature that the remedy provided for in this ordinance will not prevent the danger prior to its occurrence.

Sec. 50.00 – Effective Date

This Ordinance shall take effect and be in force upon adoption

- **Employees living south of the Neuse River on US Hwy 117 (exempt and nonexempt):**
 - The inclement weather policy was put into effect for these employees only.
 - These employees will not be penalized from Monday, October 10, 2016 through Thursday, October 13, 2016 for time away from work.
 - The employees in this category that did report to work will be compensated according to the personnel policy by being paid additional straight time pay for the hours worked.
 - Supervisors will be responsible for determining who is affected by this section.
 - This time should be noted as "other leave" on their timesheet.
 - This "other leave" will be treated similar to sick and vacation leave and, therefore, cannot cause an employee to qualify for overtime.
- **All other employees (exempt and nonexempt):**
 - These employees will be required to take vacation leave if they did not report to work or were sent home by a supervisor. We have instances that employees were told by their supervisor to go home because of no electricity, however, we can only pay for hours worked.
 - If these employees do not have sufficient vacation leave to cover the time away from work, they will go on LWOP.
 - Exceptions to this section:
 - If managers are aware of their employees being unable to report to work due to impassable roads, no leave is required to be taken.
 - If managers are aware of an employee having extenuating circumstances in regards to reporting to work, such as their home flooded, no leave is required to be taken.
 - Proof will need to be supplied to the manager under these two exceptions.
- **All employees (exempt and nonexempt), Friday, October 14, 2016**
 - All employees, regardless of their location, would be required to take leave if they did not report to work on Friday, October 14, 2016 and would normally be scheduled on Fridays.
- **Overtime during a disaster response:**
 - Exempt and nonexempt employees will be paid overtime in accordance with the personnel policy.
 - Please refer to Article III, Section 11 Overtime, for details on how overtime will be handled for both exempt and nonexempt personnel.
 - Please ensure that adequate documentation on time worked for all employees is kept during the disaster.
- Requests for exceptions to the above guidelines need to be directed to Jerilyn Lee, HR Director.

The Planning Department has received a petition from Braswett Ventures Inc. to rezone a 13.07 acre tract of land in the Fork Township from Light Industry (LI) to Residential-15 (R-15).

The property is located at the end of Eagle Place (SR 2122). The subject site is further identified as part of tax parcel id #2670390137. The tract is adjacent to Rosewood Valley subdivision and behind the former Methodist Men's warehouse located off Community Drive. The property is currently wooded. The zoning change will allow the developer to construct an 18 lot residential subdivision as an extension to Eagle Place and Rosewood Valley subdivision. The property is bordered on the north by Industrial buildings with Light industry zoning, on the east by Rosewood Valley subdivision and R-15 zoning, on the south by commercial development and community shopping (CS) zoning and by wooded tracts on the west with residential-agricultural 20 (RA-20) zoning.

The property is identified within an Urban Transition area on the Wayne County Growth Strategy map.

The proposed rezoning would support the following policies from the Comprehensive Plan.

Policy 3.8: Wayne County shall encourage a "TOWN AND COUNTRY" DEVELOPMENT PATTERN that makes the provision of county services (e.g. Sheriff's patrol, school bus pick ups, etc.) more economical and the installation, maintenance and replacement of non-sprawling infrastructure (e.g. water and sewer lines) less expensive.

Policy 4.1: Wayne County should encourage developments that help build a distinct "TOWN AND COUNTRY" DEVELOPMENT PATTERN. The intent of this policy is to preserve open space and productive farmland, minimize the costs of extending infrastructure, avoid higher taxes, and minimize traffic congestion associated with a sprawling development pattern.

Policy 4.3: Areas preferred for URBAN DEVELOPMENT shall be identified based on a variety of land suitability factors. Appropriate urban infrastructure and services (i.e. schools, fire stations, water and sewer facilities, parks, and roads) may be provided to encourage development in these areas.

Policy 4.5: RURAL LEVEL DEVELOPMENT STANDARDS (e.g. no curb and gutter, no streetlights, no sidewalks, etc.) shall generally be applied to areas preferred for rural development and agricultural production.

Policy 4.6: Whether located in an *Urban* or *Rural* area, new development should occur at DENSITIES APPROPRIATE FOR THE SITE. Density factors shall include whether the site is within an environmentally sensitive area, the type of sewage treatment available, the topography and drainage of the site, the capacity of transportation facilities serving the site, the proximity of the site to other existing services, and other relevant factors

Policy 7.6: EXISTING NEIGHBORHOODS should be protected from encroachment by incompatible land uses. At the same time, convenient services designed to be compatible with nearby residential uses may be permitted at an appropriate level of design and scale.

Policy 7.12: COMPACT, FULL SERVICE NEIGHBORHOODS offering a compatible mixture of appropriately scaled and designed structures (homes, schools, churches, parks, shopping and services, etc.) and less dependency on the automobile, shall be encouraged.

Policy 7.14: To preserve the traffic moving function of the area's major travel ways, prevent traffic accidents and avoid land locking interior land parcels, local governments shall encourage RESIDENTIAL AND COMMERCIAL DEVELOPMENT in clusters and planned developments.

Urban Transition Areas include those parts of the planning area that are not currently urban in character but that, during the next two decades, are likely to reach a level of development requiring urban services. These areas may have some services already in place including, particularly, centralized water and sewer. Other services, including stormwater management, are likely to be in place here within twenty years. *Urban Transition Areas* should be a secondary area for planning, programming and providing public urban services. Those parts of the *Urban Transition Area* that have good soils and drainage, are not in the floodplain, have road capacity available, and have sewer service nearby should generally be developed at 3 or more units per acre. Land areas constrained by poor soils and/or lack of topography and resulting flooding problems should generally be developed at lower densities.

- Rosewood Middle, Rosewood Elem.
- Water – Fork Sanitary District
- Fire – Rosewood Fire Department
- EMS – Station 2
- Transportation – Goldsboro MPO
- Water supply Watershed – Yes
- Voluntary Agriculture District – No
- Wetlands - Yes
- Board of Commissioners District - 4

Recommendation: The Wayne County Planning Board at its October 20, 2016 meeting recommended that the zoning map change be approved.

Action: A public hearing will need to be scheduled.
